PRO-NOVICE: \$40 per trial. Cash Awards and Ribbons to 5th. Course: Outrun, lift, fetch, drive through two sets of panels, pen.

NURSERY: \$43 per trial. Award to 1st. Ribbons to 3rd. Course: Outrun, lift, fetch, drive through two sets of panels, pen.

Entries may be limited. Classes may run to a Standard.
